Our accident insurance pays you a lump-sum cash benefit for injuries that come from a covered accident and can help pay for expenses that may not be covered by traditional health insurance.

### Who is eligible for accident insurance?

All Full-Time United States Employees working in the United States who are scheduled to work a minimum of 30 hours per week.

### Health screening benefits

Our health screening benefit provides a payment if you complete a health screening test. This benefit pays \$50 per screening, limited to 1 per calendar year.<sup>1</sup>

## Additional Benefits

### Standard

#### Organized sports

Provides an increase in the Common Injury Benefits (Fractures, Dislocation and Other Common Injuries), Emergency Hospitalization Benefits and/or Treatment and Other Services benefits if your accident occurs while participating in an organized sporting activity.

Benefits increased by 25%, to a maximum additional benefit of \$1,000

### What other benefits are offered as part of my coverage?

Your accident insurance may include access to benefits that can help in certain scenarios, available on your first day of coverage.

#### › Take your accident coverage with you if you leave your job (also known as “Portability”)<sup>2</sup>

If your employment is terminated, you can continue your accident insurance, and accident insurance for your insured spouse and dependent children, on a direct-bill basis.

#### › Support for your health care questions.

Through our Health Care Support program, you'll have access to trained advocates and registered nurses to help you effectively navigate your health care plan and provide support for your questions and concerns.<sup>3</sup>
